## South32 Airline Services Contract

- Alliance has entered into a new airline services contract with South32 Group Operations Pty Ltd (South32) as agent for each of South32 Cannington Pty Ltd (Cannington) and Groote Eylandt Mining Company Pty Ltd (GEMCO).
- The contract is for a ten-year term from 2020 to 2030
- Alliance has been providing airline services to the Cannington and GEMCO mine sites since 2006
- The contract will further establish Alliance's permanent presence in the Northern Territory

Alliance Aviation Services Limited ("Alliance") is proud to announce it has entered into a new airline services contract with South32, as agent for each of Cannington and GEMCO, for a ten-year term. Alliance will be the sole supplier for these services. "For the next ten years Alliance will also be servicing South32's charter requirements from Darwin. This will result in a significant increase in our permanent presence in the Northern Territory, which in turn should provide significant new opportunities for Alliance particularly in tourism."
