### Alliance Aviation Services Limited (“Alliance”) (ASX: AQZ)

#### Trading Update – Record Profit Before Tax

#### Full Year Result

Full year results for the financial year ended 30<sup>th</sup> June 2024 will be released post-market closure (as is customary) on Wednesday 14<sup>th</sup> August 2024.

The company is confident of a record Profit Before Tax that will exceed consensus forecast of \$83.9 million.

This will be an uplift in Profit Before tax of in excess of 60% over FY23.

This will include a profit in the company’s Aviation Services operation, resultant from the sale to a European operator, of five General Electric CF-34-10 engines from recently parted out E190 aircraft and from inventory. The full cash proceeds of approximately \$25 Million will be received prior to the end of this financial year, reinforcing the integral part that Aviation Services plays in company’s revenue mix.
